

PROPOSED RULES OF PROCEDURES

1 Delegate Body

The delegates to be seated at the convention shall include one woman elected by each congregational unit and the Board of the Southeastern Iowa Synodical Women's Organization (SWO).

2 Seating of Delegates

Delegates must register with the Committee of Credentials before being seated in the section reserved for delegates. Delegates are requested to be in their seats five minutes prior to the time set for the opening of the session. The roll of delegates may not be changed after 3:30 p.m., June 19, 2023, without specific approval of the convention.

3 Quorum

A majority of the registered voting delegates shall constitute a quorum.

4 Privilege of the Floor

Seat and voice shall be granted to the Bishop of the Southeastern lowa Synod or the Bishop's representative, Synod staff liaison, members of the SWO Board and the Churchwide Board representative.

5 Appointment of Parliamentarian and Committees

At the opening of the business meeting, the presiding chair shall announce the appointment of the following:

Committee of Claims

Committee on Credentials

Committee on Elections

Committee on Minutes

Committee on Nominations

Committee on Reference and Council

6 Convention Business Agenda

The presiding chair shall be granted the privilege of adjusting the agenda and calling up any item of business she deems necessary in the light of schedule and time constraints.

7 Minutes

The minutes of this convention shall be reviewed by the Committee on Minutes, approved by the Synodical Board, be printed in the GPR, and published in *Directions*; the Synodical newsletter.

8 Voting Procedures

To be eligible to vote, a delegate must be seated in the designated delegate section. No absentee or proxy voting is permitted.

9 Elections

- A All elections will be by written ballot. Please wait to mark your ballots until instructed to do so.
- B The Committee on Nominations shall nominate two persons for each vacancy. Additional nominations may be made from the floor for all elections for which nominations have been made.
- C Nominations from the floor for all officers, board members, and the nominating committee shall require permission of the nominee and biographical information with proper coding format.
- D The President, Vice President, Secretary, Treasurer, and Board Members shall be elected for two-year terms. A majority of votes cast shall be necessary for election to the Board.
- E Three persons shall be elected for a one-year term to serve on the Committee on Nominations. The person receiving the highest number of votes shall serve as committee chair.

10 Motions and Resolutions

Any delegate may make a motion or present a resolution from the floor if the motion or resolution is germane to the question under consideration. If any delegate desires to add any item of new business that is not germane to a pending question, she shall:

A Write a motion or resolution on the appropriate form.

B Provide the signature of three delegates.

Deadline for submitting resolutions to the Committee on Reference and Counsel was June 1, 2023. Resolutions pertaining to action that could not have been anticipated prior to June 1, 2023, may be submitted to the Resolutions Committee no later than June 8, 2023.

11 Speeches

All speeches in general discussion, unless otherwise determined by a two-thirds vote of the convention, shall be limited to two minutes. No person shall speak more than twice on the same issue without consent of the assembly and only after all others have spoken. Speakers must use the microphone and identify themselves by name, congregational unit, and city to be recognized by the chair. This includes all addresses made to the assembly, motions, and seconds to motions.

12 Attendance

Delegates shall be present at all business sessions.

13 Distribution of Materials

After the convention is in session, permission to distribute materials not issued from the SWO must be secured from the Committee on Reference and Counsel.

14 Promotional Activities

The wearing of promotional buttons or slogans, the distribution of materials or the carrying of placards to promote one candidate over another is not permitted at the Gathering.

15 Governing Parliamentary Law

Robert's Rules of Order, 11th Edition, shall be the governing laws of this convention, except as otherwise provided in the Rules of Procedures.

Rev. Amy Current is a pastor in The Evangelical Lutheran Church in America (ELCA) and has served the Southeastern lowa Synod in the office of bishop since 2020. She is a graduate of Concordia College, Moorhead, MN (B.A.) and Wartburg Theological Seminary (M.Div.).

Bishop Current serves on the boards of Grand View University, Lutheran Services in Iowa, Wartburg College, and Unity Point Health – Des Moines.

Bishop Current is married to Rev. Dr. Samuel Giere, who serves as professor of homiletics and biblical interpretation at Wartburg Theological Seminary. They have two children.



Pastor Tania Schramm, Gathering Chaplain – Pastor at Grace Lutheran Church, Adel, Iowa

Tania Schramm serves as Pastor at Grace Lutheran Church in Adel, Iowa, where she has been since September 2022. (Fun fact: Grace is also where she served on internship in 2017-18!) Tania received her Master of Divinity from Wartburg Theological Seminary in 2019. She also

Kim Crawford - Circle of Freedom



Kim is the founder and Executive Director of Circle of Freedom. In 2012, she was given the opportunity to begin a weekly Bible Study with the women at the county jail. This ministry immediately captured her heart. It quickly expanded to mentoring and discipleship with women after they were released, but there were still women who needed more intensive help. The vision for the women's residential home had been on her heart for several years. In 2019, it was time to move on from her 35-year career with the Farm

Service Agency of USDA and step into the vision. Looking back, she says God has been preparing her for this in so many ways all her life. In Kim's words, "It is a humbling privilege to have these women share their lives with me and allow me to share the good news of freedom, a fresh start, and a future that Jesus has for each of them. Just telling them isn't enough. We must walk with them until they have a solid foundation of faith and life re-establishment. I am blessed to have become life-time friends with some of the most amazing women on their journey!"

Kim is an ordained chaplain and is fully appointed with US Missions in Correctional and Specialized ministries. Kim and her husband Rick have been married for 40 years, serving together in their local church, New Beginnings Worship Center in Corydon, Iowa for over 30 years. They have three grown sons, lovely daughters-in-law, and 4 amazing grandchildren. She enjoys spending her free time with her family and friends and being outside.

Pastor Sarah Trone Garriott – Iowa Senate and Des Moines Area Religious Council



Sarah Trone Garriott has always felt called to serve. Over the course of her life, this call has taken many forms. It was what led her to join AmeriCorps right out of college, to help victims of domestic violence. It was what sustained her as a hospital chaplain, caring for people during times of crisis. It was what inspired her to become a Lutheran minister, to provide leadership to communities of faith. And it was what took her out of the parish and into the nonprofit world, to bring diverse people together around a

common cause of caring for our neighbors in need of food assistance.

Sarah Trone Garriott was born in Minneapolis, Minnesota. She earned a Bachelor of Arts degree in history from the College of St. Scholastica, a Master of Theological Studies from Harvard Divinity School, and a Master of Divinity from the Lutheran School of Theology at Chicago.

Senator Trone Garriott is currently a member of the Iowa State Senate, representing Iowa's District 14. In the State Senate, Senator Trone Garriott has focused on helping working families: good schools, clean water, quality accessible healthcare, economic opportunity, and civil rights. She's sponsored legislation to provide paid family leave, and improve access to quality, affordable childcare. It is her priority that Iowans have a voice in state government and that elected leaders are accountable to the people. As such, she works hard to educate Iowans about state government and their opportunities to take part in the process. She is present in the community and makes every effort to be accessible to her constituents. She serves on the Education Committee, Human Resources Committee, Health & Human Services Appropriations Subcommittee, and is the ranking member on the Natural Resources & Environment Committee.

served as pastor at Martin Luther Evangelical Lutheran Church in Bergton, Virginia, and at Faith Lutheran church in Clive, Iowa.

Her career experience includes working as the coordinator of interfaith engagement for the Des Moines Area Religious Council, She co-founded Iowa Interfaith Exchange, which describes itself as "a partnership of interfaith organizations working in the greater Des Moines area." After earning her undergraduate degree, Garriot worked as a volunteer with AmeriCorps VISTA in New Mexico.

Sarah Trone Garriott is married to William Garriott, a professor at the Drake University Law School. The couple have two sons.

As a parent, Sarah knows why it matters so much that our state invest in child care and public education. As a community member, she has personally encountered how the lack of affordable housing, stagnant wages, and regressive policies have discouraged people from staying in our state or moving to lowa. As a pastor, she's seen people of all ages in the community struggle to find mental health care. And as a nonprofit leader, she knows that real change is possible when state government works collaboratively with nonprofits, business leaders, and the people of this state.

Freddie L. Jordan, Ph.D - <u>Women of the Evangelical Lutheran Church in</u> America - Executive Board Member



Vice President of the Board, '21-23' Women of the Evangelical Lutheran Church in America Freddie Jordan was elected as secretary to the executive board of Women of the ELCA in July 2017, serving through 2021 on the programs and communication committee and the executive committee. In 2021, she was elected vice president and currently serves on the budget and finance committee and the executive committee.

Freddie served as vice president of the Southern Ohio Synodical Women's Organization (6F) and supported programs

for Lutheran Social Services, Lutheran World Relief, and anti-human trafficking initiatives.

As a resident of Columbus, Ohio, Freddie had been an active member of St. Philip Evangelical Lutheran Church for over two decades. She has served as a member of the church choir, Sunday school education, and works with Women of ELCA's outreach to clients at Twin River Valley Behavioral Hospital, Faith Missions, Lutheran Social Services – Nancy's Place, and other such programs supporting women affected by domestic violence. She has also served on St. Philip's church council in several capacities, appointed and elected, including president of the congregation.

Freddie is a native of Mississippi, where she completed her education in the sciences at Jackson State University. She received her Ph.D. in Biochemistry and Nutrition, Meharry Medical College, Nashville, Tenn., followed by a postdoctoral fellowship in neuroscience. She has several publications in reviewed peer research articles and abstracts.

Much of her professional career has been spent as a Buckeye at Ohio State University, Columbus, in academic, research, and professional roles.
